## Crows Nest Rotary Market Terms and Conditions

**Trading Time: 9:00 pm – 3:00pm, third Saturday of each month**

The Crows Nest Rotary Market (the Market) is an arts, crafts and food market operated by members of the Rotary Club of North Sydney Sunrise (RCNSS, the Operator). The Market is run by volunteers and helps to raise funds for local, national and international charities supported by the RCNSS. We seek to provide a friendly and co-operative environment for all stakeholders however we do have terms and conditions to avoid disputes or confusion between the Operator and stallholders.

The Market is held on public land owned by North Sydney Council. These terms and conditions include any terms and conditions required by North Sydney Council, or directions Council officers may give about the operation of the Market.

1. The RCNSS is the Operator of the Market. The Operator may cancel an individual Market day due to weather conditions, construction activities or other circumstances that may risk the safe and convenient operation of the Market. The Operator will provide stallholders as much notice as possible if a Market is cancelled, noting that weather conditions or unforeseen events may require cancellation on the day of the Market.
2. All bookings, once confirmed, must be paid in advance of the booked date.
3. Once a booking is made, payment is due regardless of attendance. Failure to attend may prejudice participation in future Markets, at the discretion of the Operator. If a Market is cancelled by the Operator, payments will be credited to a future Market. The transfer of a booking under these circumstances will be mutually agreed by the Operator and stallholder.
4. A stallholder may cancel a booking by emailing the Operator at least 7 days prior to the Market day. Payments made will be credited toward a future Market. Bookings cancelled within 7 days of the Market day require payment in full and no credit will be provided for such payments.
5. Stallholders are responsible for their stall and goods. The Operator does not accept any responsibility for damage to and/or theft from stalls.
6. Stallholders must have current public liability insurance to the minimum value as specified by the Operator and details of the insurance must be provided at the time of booking.
7. Stallholders shall provide everything necessary for the display and sale of their goods including tables and marquees and the means to transport them into the Market. Stallholders are responsible for the safety of all such items and ensuring they are secure in windy conditions.
8. Stallholders will be allocated a specific, numbered space for their stalls. The Operator will endeavour to cooperate with all stallholders to ensure spaces are allocated in a way that meets the needs of stallholders. The Operator reserves the right to make final decisions about the allocation of spaces, which may vary from one Market to the next.
9. The Operator reserves the right to not accept a stallholder application.
10. **Power supply – the Market does not provide power to stalls.**
11. The Operator does not accept applications for religious or political stalls at the Market, which is a shopping market only.
12. The Operator may limit the number or nature of stalls selling food intended for immediate consumption. This is to ensure that the Market does not adversely impact local food and beverage businesses. All food stallholders must strictly comply with all relevant food preparation and public health regulations and standards, including all North Sydney Council requirements.
13. Stallholders must be ready to commence trading by 9.00am and as far as possible, stalls should not be left unattended.
14. At the close of trading, stallholders must take away all stall equipment, unsold items and rubbish. Please leave the stall allotment tidy.
