

Bankstown Sports 'Luxury Wheels & Mega Deals' Members Draw

15 September to 22 November 2026

Terms and Conditions

1. About the Promotion:

1. Bankstown Sports 'Luxury Wheels & Mega Deals' Members Draw (referred to as 'Promotion' or 'Members Draw' commences from Tuesday 15 September 2026 and concludes on Sunday 22 November 2026 with weekly draws commencing from Tuesday 15 September 2026.
2. The Members Draw will consist of 30 draw nights.
3. The total prize pool for the Promotion is \$265,000, comprising:
 - a. Weekly Draw cash prizes valued at \$145,000;
 - b. Mid-Promo Draw bonus cash prizes valued at \$10,000;
 - c. Final Night bonus cash prizes valued at \$15,000; and
 - d. One (1) 2026 Range Rover Evoque in black as the Major Prize, valued at \$95,000.
4. The promoter is Bankstown District Sports Club Limited ABN 88 000 243 916 (referred to as 'BDSC') of 8 Greenfield Parade Bankstown NSW 2200, phone 02 9722 9888.
5. Entry into the Promotion is subject to the acceptance of these Terms and Conditions.
6. If there is any inconsistency between the Terms and Conditions and anything else that refers to this Promotion, these Terms and Conditions will prevail.
7. Each draw will be conducted by a Promotional Host at Bankstown District Sports Club located at 8 Greenfield Parade, Bankstown NSW 2200, using a promotional system & computerised virtual barrel (virtual barrel). Winners will be drawn by their BDSC Membership number, and it will be displayed on selected screens at BDSC. The membership number will also be announced over the public address system. In the event of a technical failure, membership numbers may not be displayed on screens and/or draws may be postponed. In the case of a postponed draw, an extra draw will be selected the following week on the scheduled draw day.

2. Eligibility:

8. Subject to these Terms and Conditions, entrants for the Promotion must be:
 - a. Financial and current members of BDSC throughout the promotional period to be eligible to win (Members),
 - b. Over the age of 18 years; and
 - c. Agree to and comply with these terms and conditions.

3. Excluded Participants:

9. You cannot participate in the Promotion if:
 - a. You have been suspended from BDSC at the time of the draws. You will not be eligible to enter the draw or claim prizes.
 - b. You are a director, employee or contracted personnel of BDSC (or any related entity) or you are an immediate family member of a director, employee or contracted personnel of BDSC (or any related entity).

4. The Weekly Draws Nights:

10. The Weekly Draw nights will be conducted every Tuesday, Thursday and Sunday, from Tuesday 15 September to Thursday 19 November.
11. Each Weekly Draw night will consist of three (3) draws at the following times:
 - a. 7:00PM
 - b. 8:00PM
 - c. 9:00PM
12. Each Weekly Draw night offers one (1) cash prize valued at \$5,000. Draws will continue until the prize is successfully claimed or the final draw of the night has concluded.
13. Each selected winner will have four (4) minutes to claim their prize from the promotional host located at the Rainforest Lounge. For each draw at 7:00PM and 8:00pm there will be one (1) draw only.
 - a. If the prize remains unclaimed, the prize value will remain at \$5,000 for the next scheduled draw.
 - b. Once the \$5,000 prize has been successfully claimed on a draw night, no further draws will be conducted that night.
14. The 9:00PM draw will continue until the prize is claimed.
15. Any member who is drawn and claims a prize remains eligible to be drawn again in future weekly draws.
16. BDSC reserves the right to vary the draw location within the Club.

4.1 The Mid-Promo Draw (Sunday 25 October):

17. The Mid-Promo Draw will be on Sunday 25 October 2026.
18. The Mid-Promo Draw will follow the same schedule as the Weekly Draws, with the addition of two (2) bonus cash prizes valued at \$5,000 each to be drawn after 9:00PM at approximately 9:30PM and 10:00PM following the conclusion of the \$5,000 Weekly Draw prize.
19. Each selected winner will have four (4) minutes to claim their prize from the promotional host located at the Rainforest Lounge. There will be a maximum of four (4) redraws after the initial bonus draw.
 - a. If the bonus prize remains unclaimed, the prize value will jackpot and be added to the next scheduled draw.
20. Depending on the number of bonus prizes claimed, the bonus prizes awarded may consist of:
 - a. Two (2) cash prizes of \$5,000;
 - b. One (1) cash prize of \$10,000.
21. The bonus prize draw will continue until a winner is found.
22. Any member who is drawn and claims a prize remains eligible to be drawn again in future weekly draws.

4.2 The Final Night Draw – Major Prize (Sunday 22 November):

23. The Final Night Draw will be on Sunday 22 November from 6:30PM.
25. The Final Night Draw will have one (1) 2026 Range Rover Evoque in black valued at \$95,000, with the draw commencing from 9:30PM.
26. The winner will be selected from eligible members who are physically present within the Club premises at the time of the draw and have activated their entries in accordance with section 5.5.

27. If a selected prize winner does not claim their major prize within a four (4) minute timeframe, another member will be drawn until a winner is found.

4.3 The Final Night Draw – Bonus Prize (Sunday 22 November):

28. The Final Night Draw will have three (3) bonus cash prizes valued at \$5,000 each drawn from the following times:
- 6:30PM
 - 7:30PM
 - 8:30PM
29. Each selected winner will have four (4) minutes to claim their prize from the promotional host located at the Rainforest Lounge. For each draw, there will be a maximum of four (4) redraws after the initial draw.
- If the prize remains unclaimed, the prize value will jackpot and be added to the next scheduled draw.
30. If the prize remains unclaimed following the final draw at 9:30PM, the selected final winner (if identifiable) will be contacted by the Promoter using their membership details on the following day.

5. How to Earn and Activate Entries:

5.1 Automatic Member Entry

31. Each eligible member recorded as of Tuesday 15 September 2026, 9:00AM (the qualifying deadline) will automatically receive one (1) entry into the virtual barrel.
- Any members who signed up after the qualifying deadline will not receive one (1) automatic entry into the virtual barrel for the promotion.

5.2 Member Swipe and Spend Entry

32. Members may earn additional entries by doing any of the following:
- Members will receive one (1) entry into the virtual barrel for swiping or scanning their own Membership card at the nominated kiosks once every hour daily during the promotional period.
 - Members will receive one (1) entry into the virtual barrel for every \$10 spend in a single transaction at dining and beverage outlets at BDSC and venues (*excluding San Churro, Lady Banks Rooftop, Al Aseel, Ultrafade and Monkey Mania*) during the promotional period. Entries will be allocated subject to the following conditions:
 - One membership card can be swiped or scanned per transaction to earn the entries. The membership card must be scanned or swiped at time of transaction by the Member.
 - Members can make a purchase through BDSC's online ordering system (known as 'me&u') to earn entries.
 - Members must enter their membership number into me&u before payment, to earn entries. Entries will not be made retroactive if a member does not enter their membership number at time of transaction.
 - Me&u is a separate legal entity and is entirely unrelated to BDSC. BDSC is not responsible for any entries that are provided to it late or otherwise not provided to it by me&u.
 - All POS transactions made during the Promotional period but before the Weekly Draw will be included in the Virtual Barrel (entry may take up to 15 minutes to be counted due to processing time).

5.3 Member Tier Entry Multiplier

33. All entries, including the automatic membership entry and any swipe or spend entries, will receive the following multiplier based on the Member's tier status:
- Diamond: Five (5) times multiplier
 - Platinum: Five (5) times multiplier
 - Gold: Three (3) times multiplier
 - Silver: No multiplier
 - Bronze: No multiplier
 - Basic: No multiplier

5.4 Entry Accumulation

34. Entries do not reset after a draw. All entries are cumulative and will remain in the virtual barrel for the duration of the Promotion.
- Any entry selected in a draw will be removed from the virtual barrel, regardless of whether the prize is claimed. All other entries held by the Member will remain in the virtual barrel.

5.5 Entry Activation

35. To be eligible for the Final Night Draw, members must activate their entries by swiping their membership card at a nominated kiosk between 3:00PM and 10:30PM on the day of the relevant draw. Entries that have not been activated will not be eligible for that draw.
36. Members are responsible for ensuring their entries have been activated on the draw night to be eligible. Failure to activate entries will render all accumulated entries ineligible.

6. Major Prize:

37. The Major Prize is one (1) 2026 Range Rover Evoque in black, valued at \$95,000.
38. The winner must present valid photo identification and their Membership card to claim the Major Prize. If the winner is unable to provide satisfactory proof of identity or membership, the prize may be forfeited, and no substitute prize will be offered.
39. The winner of the Major Prize must hold a valid Australian Driver Licence to enable registration of the vehicle in their name. If the winner does not hold a valid Australian Driver Licence, the Major Prize may be transferred to a person nominated by the winner, subject to the Promoter's approval. Such approval is at the sole discretion of BDSC and will only be considered where the original winner does not hold a valid Australian Driver Licence.
40. By accepting the Major Prize, the winner acknowledges and agrees that:
- All registration, transfer, insurance and ongoing vehicle ownership costs, including but not limited to comprehensive and third-party insurance, are the sole responsibility of the winner.
 - A copy of the winner's valid Driver Licence must be provided to the Promoter to facilitate vehicle registration and transfer.
 - The winner will receive the vehicle displayed in the Mona St Foyer at Bankstown District Sports Club.
 - BDSC is not responsible for any defect, fault, malfunction or warranty claim associated with the vehicle and accepts no liability in relation to the vehicle supplied by Suttons Motor Group.
 - BDSC makes no representations or warranties, express or implied, regarding the quality, suitability, merchantability or fitness for purpose of the vehicle.
 - The Major Prize is not transferable, exchangeable or redeemable for cash.

- g. The Major Prize cannot be collected on the Final Night Draw. Collection arrangements will be made with the winner for the following business day or another mutually agreed date.
- 41. Further information regarding the vehicle, including specifications, features, warranty and insurance requirements, may be obtained directly from Suttons Motor Group or the vehicle manufacturer.

7. General Terms and Conditions

- 42. Members must be physically and personally present at Bankstown District Sports Club (BDSC) to claim their prize within the claim period.
- 43. Suspended members at the time of the draw are not eligible to enter the draw or claim prizes.
- 44. Participation is open to all those in venue over the age of 18, except employees and immediate families of the Promoter and their associated companies and agencies and participating outlets. Immediate family means any of the following: spouse, ex-spouse, de facto spouse, child, or stepchild (whether natural or by adoption), parent, stepparent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, stepsister, or 1st cousin.
- 45. By participating in this draw, you agree that if you are a winner, BDSC may use your name, likeness, and photograph for promotional purposes in any media, without further consent or compensation. This includes, but is not limited to, website announcements, social media posts, printed materials, and other marketing activities related to the draw or future promotions.
- 46. In the event of a technical failure (*including but not limited to the display screens, PA system or draw system*), draws may be postponed or cancelled. The cancellation or postponement of a draw is strictly at management discretion, and negotiation will not be entered into. In the event of a cancellation, prizing of cancelled draws is forfeited and the cancelled draws value will be added to the following draw.
- 47. In the event of a prize winner not being drawn on any weekly draw night the Club reserves the right to continue the final draw for ninety (90) minutes from the initial draw time. If, after the 90-minute period any prize remains unclaimed, the selected final winner (if identifiable) will be deemed the winner and will be contacted by BDSC using their membership details within three (3) business days.
- 48. BDSC accepts no responsibility for any technical errors, malfunctions, or failures (including but not limited to kiosk systems, membership card readers, electronic draws, or communication networks) that may affect the conduct of the Weekly Draws. In the event of such errors, the Club reserves the right to take any necessary action, including cancelling, postponing, or rescheduling a draw, without liability to any participant.
- 49. All winners are required to present proof of identity to claim their prize.
- 50. BDSC is not permitted to issue any more than \$5,000 prize money in cash. Any prize money exceeding \$5,000 must be awarded as an EFT.
- 51. In the event of any dispute concerning the conduct of this promotion, the eligibility of an entrant, the calculation of entries, the prize draw process, the awarding of any prize, or the interpretation of these Terms and Conditions, the entrant must first notify BDSC in writing, providing full details of the dispute. Bankstown Sports Club will investigate the matter and provide a written determination. If the entrant is dissatisfied with the determination, the parties agree to attempt to resolve the dispute through good-faith discussions and, if necessary, mediation before commencing legal proceedings. This

clause does not affect any rights an entrant may have under applicable legislation, including the Australian Consumer Law.

52. This competition is a game of chance and skill plays no part in determining the winner.

53. Bankstown District Sports Club reserves the right to amend, suspend, cancel, terminate or withdraw this Promotion at any time without prior notice, subject to any applicable laws or regulatory requirements.
